Pursuant to NRS 116.31034 (5), if the number of candidates is equal to or less than the number of open seats on the Board, the Association will <u>not</u> prepare or mail any ballots to units' owners and the nominated candidates shall be deemed to be duly elected to the executive board, unless a unit's owner nominates himself within 30 days after the date of the "No Ballot" notice and such nomination(s) causes the number of candidates to exceed the number of open seats on the Board.

Your Executive Board Candidate Statement must be received by the Management Company no later than <u>5:00PM March 16, 2022</u> for your name to be included on the ballot.
